

**OCTOBERFEST SOUTHERN STYLE

FOOD VENDOR AGREEMENT  
\$130.00**

It is agreed, the undersigned (hereafter know as VENDOR) will rent booth space at the Octoberfest Southern Style Festival (hereafter referred to as Octoberfest Southern Style) as outlined below.

VENDOR will utilize a designated space at Dillon Park during Octoberfest Southern Style. The space shall be approximately 20 feet wide by 20 feet deep. The exhibit may not exceed fifteen (15) feet in height. **Exhibits must not obstruct the general view of adjoining booths.** Any deviation from these regulations must be obtained in advance in writing from the Octoberfest Southern Style Board of Directors.

Space is first come-first served. The Board of Directors reserves the right to relocate display areas for the benefit of the VENDOR or for the benefit of Octoberfest Southern Style. VENDOR acknowledges the competitive spirit and accepts any and all other vendors at Octoberfest Southern Style as fair and equal competition.

**VENDOR agrees to participate for the full duration of Octoberfest Southern Style, which shall be from 12:00 noon to after the fireworks at approximately 9:00 p.m.** It is understood that setup of vendor space will begin at 4:00 p.m. the day prior to Octoberfest Southern Style and must be completed by two (2) hours prior to the actual start time of the festival. **All booths must be removed from Dillon Park no later than midnight the day of the festival.**

**VENDOR will forfeit Booth spaces not occupied by 10 a.m. on October 13, 2007. That space will be resold, reassigned or designated to others without refund.**

OCTOBERFEST SOUTHERN SYTLE will provide space only. The VENDOR must provide other supplies, all needed tables, chairs, and etc. A **MINIMUM** source of electricity is available.

Absolutely no alcoholic beverages can be served or consumed during the festival except in designated area as approved by the Board of Directors.

In the event of inclement weather, it shall be the responsibility of the Board to determine if OCTOBERFEST SOUTHERN STYLE shall be postponed. In the event that the determination is made to postpone, OCTOBERFEST SOUTHERN STYLE shall be the next day with modified hours.

The OCTOBERFEST SOUTHERN STYLE Board of Directors reserves the right to refuse any VENDORS that it deems non-compatible with the OCTOBERFEST SOUTHERN STYLE theme. The Board of Directors also reserves the right to limit the number of VENDORS. All VENDORS must have or obtain a Sumter Business License. Proof of same shall be provided prior to setup. All VENDORS, if applicable, must meet all South Carolina DHEC regulations. In the event the DHEC requirements are not met no refund shall be given.

The VENDOR agrees to protect, save and keep the OCTOBERFEST SOUTHERN STYLE Board of Directors, Sumter County, participating sponsors and their representatives, employees, and agents forever harmless for any and all damages or charges imposed for violation of any law or ordinance, whether occasioned by the negligence of the VENDOR or the representatives, agents or employees of the VENDOR or those persons acting under the express or implied authority of the VENDOR. The VENDOR also agrees to comply with all applicable terms, conditions, rules and regulations of OCTOBEREST SOUTHERN STYLE. The VENDOR assumes complete responsibility and liability for all loss, damage, or destruction of his/her property, employees, agents and guest. The OCTOBERFEST SOUTHERN SYTLE Board of Directors, Sumter County, participating sponsors or employees thereof will not be liable for any loss, damage or destruction of VENDOR'S property by theft, fire, accident or any other cause. The VENDOR also assumes full responsibility and liability for all injury to any and all person or property or personal injury caused by the VENDOR or its agents, representatives or employees. The VENDOR will indemnify and hold harmless the OCTOBERFEST SOUTHERN STYLE Board of Directors, Sumter County, participating sponsors, directors, officers, agents, representatives and employees against any and all liability whatsoever arising from any and all damage to property or personal injury or loss caused by the VENDOR, it's agents, representatives, employees or other such persons.

All matters and questions not covered by the terms of this agreement are subject to the decision of the OCTOBERFEST SOUTHERN STYLE Board of Directors. The Board shall have the authority to promulgate, interpret, and enforce all rules and regulations and to make any amendments necessary for the orderly conduct of OCTOBERFEST SOUTHERN STYLE. Any variations of the terms must be in writing and signed by a duly authorized representative of the OCTOBERFEST SOUTHERN STYLE Board of Directors.
